- 1. Presentation #3: Municipal Employees, Department of Public Works, Highway, Water, Sewer, and Lighting A summary of the number of Village and Town municipal employees and their salaries and benefits was provided to the committee, along with details on the Public Works, Highway, Water, Sewer, and Lighting. The committee had the following comments and corrections to the presentation:
 - i. The Village Planning Board members are paid but their compensation is reported in the AUD as contractual expenses, not personal services, so their salaries are not shown in these tables. The committee went over the Planning Board contractual services in last month's meeting.
 - ii. The Village pays 75% of the medical benefit and the employee is responsible for 25%. The Town pays for 80% of the medical benefit and the employee is responsible for 20%.
 - iii. Slide 8 corrected to show that the Legislative Board is paid once a month; and the Cemetery salary is for the Three Mile Bay Cemetery manager.
 - iv. Slide 9 corrected to show that the Misc. Fund Public Health Officer salary covers 2 staff, a medical officer and a doctor, who are each paid \$1,000.
 - v. Slide 10 note added to clarify that the Town Workers Compensation Insurance is covered by the County and the Town pays for that insurance through a County charge back.
 - vi. Slide 16 added that the DPW remove dead trees as needed.
 - vii. Slide 18 added that the DPW restructure the beach in May before it opens
 - viii. Slide 28 corrected "water system" to "sewer system" in first paragraph
 - ix. Slide 37 corrected the number of abandoned cemeteries from 6 to 7
 - x. Slide 38 corrected Chevrolet **Dump** Body Pick-up
 - xi. Slide 41 corrected address for property #16 to S of Co Rte 57 (incorrect address has been entered into table)
 - xii. Slide 46 corrected total cost to \$29,218.83 (extra number was entered into total)
 - xiii. The committee discussed how a new water district would be formed in the event of a village dissolution, taking the 18 outside village users who pay more than inside users into consideration. The new district would be formed with all of the village users, including outside users, and the rates for water customers may change. This will be discussed in more detail during the Alternatives Phase of this study project.
 - xiv. The committee briefly discussed what would happen to Village contracts in a dissolution scenario. Any contracts in place would be turned over to the Town after dissolution.
- 2. The next meeting will be August 28 and will cover local laws and fire/rescue services.
