Local Law No. 1
of The Year 1980

A Local Law Establishing Dog License Fees

By Councilman Francis Chauoustie

Be it enacted by The Town Board of The Town of Lyme

Section 1. Pursuant to Section 110(4) of Article 7 of the Agriculture and Markets Law, the categories of spayed/neutered and unspayed/unneutered dogs are hereby increased \$2.50 each, establishing such new fees as follows:

\$5.00 for spayed/neutered dogs

\$10.00 for unspayed/unneutered dogs

Section 2. This Local Law shall become effective December 1, 1980.
