Section 1. Whenever required by any law to publish or post a copy of the text of any local law, ordinance or regulation, the Town of Lyme shall be authorized to publish or post an abstract or summary thereof describing the same in general terms and shall note that the complete text of the law, ordinance or regulation is on file with the Town Clerk's Office.

Section 2. The Town Clerk shall, to the extent practicable, make available for inspection by any interested person at the Town offices a copy of any such local law, ordinance or regulation, any proposed local law, ordinance or regulation or any other document required by law to be available to the public.

A reasonable charge set by the Town Clerk to defray the cost of making any such copy available for inspection is hereby authorized and may be imposed.

Section 3. This local law shall amend and supersede the requirements of Town Law Sections 133 and 134 to publish in the official newspapers a copy of all ordinances and amendments thereto, and shall take effect on its filing as required by law.

Section 4. This local law shall amend and supersede the requirements of Town Law Sections 264 and 265 to publish the full text in the official newspapers a copy of
