3.2 BASIS FOR ESTABLISHING THE AREAS OF SPECIAL FLOOD HAZARD

The areas of special flood hazard have been identified by the Federal Emergency Management Agency on Flood Insurance Rate Maps enumerated on Map Index No. 360343B 01-06 dated April 15, 1986.

The above documents are, hereby, adopted and declared to be a part of this Local Law and are filed at the Town of Lyme Clerk's Office.

3. This Local Law shall take effect immediately upon filing with the Secretary of State.
