SECTION 2. AUTHORITY AND PURPOSE

- A. This law is enacted pursuant to the authority granted by Articles 2 and 3 of the Municipal Home Rule Law, and by Article 7 of the Agriculture and Markets Law.
- B. The purpose of this law shall be to provide for the setting of local fees in excess of those mandated by statute.

SECTION 3. LICENSE FEES

The fee for a license required under Section 109 of Agriculture and Markets Law in the Town of Lyme shall be as set forth on the following schedule:

- A. \$7.50 for each spayed or neutered dog, said fee comprised of the \$2.50 State fee and a \$5.00 local fee as authorized by Section 110 of the Agriculture and Markets Law.
- B. \$12.50 for each unspayed or unneutered dog, other than a purebred breeding dog licensed pursuant to Section 110 (2) of the Agriculture and Markets Law, said fee comprised of the \$7.50 State fee and a \$5.00 local fee as authorizee by Section 110 of the Agriculture and Markets Law.

SECTION 4. SUPERCESSION

This local law hereby supercedes any and all provisions of existing resolutions, ordinance or local law of the Town of Lyme inconsistent with the provisions of this local law.

SECTION 5. EFFECTIVE DATE

This law shall take effect upon its filing with the Secretary of State.
