A local law to amend the water rates in the Town of Lyme.

Article 1. - Authority. The Town Board of the Town of Lyme, pursuant to the authority granted it under Articles 12 and 12a of the Town Law and Sections 10 and 20 of the Municipal Home Rule Law of the State of New York, hereby enacts as follows:

Article 2. - Statement of Purpose and Finding. The Town Board of the Town of Lyme has determined that it is necessary to review water in order to generate sufficient revenues to cover all budgetary expenses for the year starting January 1, 2010. It is the purpose of this local law to amend such rates.

Article 3. - Enactment. The Town Board of the Town of Lyme hereby enacts the water rates follows:

District #1 Debt \$20.00
O&M \$23.00

District #2 Debt \$47.13
O&M \$23.00

District #3 O&M \$20.00

District #4 Debt \$32.00
O&M \$18.00

Article 4. - Severability. If any part of this Chapter shall be found to be void, voidable, or unenforceable for any reason whatsoever, it shall not affect the validity or enforceability of any remaining section or provision of this Chapter.

Article 5. - Effective Date. This local law shall take effect immediately upon filing with the Secretary of State.
