Section 1. Legislative Authority

The Village Board of the Village of Chaumont, pursuant to the authority granted to it by Article 17 of the General Municipal Law; the Municipal Home Rule Law; and the Resolution, Findings and Order adopted by the Town Board of the Town of Lyme and Village Board of the Village of Chaumont hereby enacts as follows:

Section 2. Statement of Purpose

The following described territory situated in the Town of Lyme shall be annexed into the Village of Chaumont:

- A. Lands owned by George and Mary Sipos located at 12570 NYS Route 12E in the Town of Lyme, New York. The subject property is also known as tax parcel number 62.00-2-38; and
- B. Lands owned by Elizabeth Bourquin located at 12573 NYS Route 12E in the Town of Lyme, New York. The subject property consists of approximately 126 feet by 125 feet and is also known as tax parcel number 62.00-2-18;

Section 3. Effective Date

This Local Law shall take effect upon filing with the Office of the Department of State as required by the provisions of the Municipal Home Rule Law and the General Municipal Law.
