It is the purpose of this local law to correct that error by increasing salary of the Highway Superintendent for 1998.

Article 3. - The Town Board of the Town of Lyme hereby amends the 1998 Town budget by increasing the salary of the Town Highway Superintendent from \$33,000.00 to \$35,500.00.

Article 4. - Severability. If any part of this Chapter shall be found to be void, voidable, or unenforceable for any reason whatsoever, it shall not affect the validity or enforceability of any remaining section or provision of this Chapter.
