A local law	to amend the current senior citizen real property
	tax exemption.
Be it enacte	d by the Town Board of the

Article 1. - Statement of Authority. The Town Board of the Town of Lyme, pursuant to the authority granted it under Section 467 of the Real Property Tax Law and Sections 10 and 20 of the Municipal Home Rule Law of the State of New York, hereby enacts as follows:

Article 2. - Purpose and Findings. The Town Board of the Town of Lyme has found that certain hardships exist to senior citizens in the Town of Lyme who turn sixty-five years of age after the taxable status date of March 1 of any given year. The Assessor has requested permission, pursuant to Real Property Tax Law, Section 467(5), to amend the current senior citizen exemption of the Town to increase the amount of eligible income they may have and still qualify for such exemption. The Town Board of the Town of Lyme hereby finds that it would be in the best interest of the residents of the Town of Lyme to make such a change.

Article 3. - Enactment. The Town Board of the Town of Lyme, hereby repeals all prior local laws granting exemptions to senior citizens under Section 467 of the Real Property Tax Law and in its place and stead adopts the new provisions for such exemption:

"Any person who shall turn 65 years of age during the calendar year which tax roll is filed shall be eligible to apply for this exemption, even though their birthday may occur after the taxable status date. The Assessor of the Town of Lyme is hereby authorized to grant an exemption to such person, provided proper application is made prior to the taxable status date. Such exemption shall be granted on the following basis:

Article 4. Severability. If any part of this Chapter shall be found to be void, voidable, or unenforceable for any reason whatsoever, it shall not effect the validity or enforceability of any remaining section or provision of this chapter.

Article 5. Effective Date. This local law will take effect immediately upon filing with the Secretary of State.
