Article 1. - Authority. The Board of Trustees of the Town of Lyme pursuant to the authority granted it under Section 27 of the Town Law and Sections 10 and 20 of the Municipal Home Rule Law of the State of New York hereby enacts as follows:

Article 2. - Statement of Purpose. The Town Board of the Town of Lyme has found that it is necessary and appropriate to provide additional compensation to the Town Clerk over and above that which was provided for in the final adopted Budget. The amount in the final budget as reported had inadvertently decreased the Clerk salary from \$28,000.00 to \$24,000.00 per year. It is the purpose of this local law to authorize an increase of the Town Clerk's salary to restore the Clerk's salary to \$28,000.00.

Section 3. The Town Board of the Town of Lyme hereby enacts as follows:

"The Town Clerk of the Town of Lyme salary for 2006 shall be increase by an amount of \$4,000.00 from \$24,000.00 to \$28,000.00 per year.

Article 4. - Severability. If any part of this Chapter shall be found to be void, voidable, or unenforceable for any reason whatsoever, it shall not affect the validity or enforceability of any remaining section or provision of this Chapter.

Article 5. - Effective Date. This local law is enacted subject to permissive referendum. This local law shall therefore be effective upon filing with the Secretary of State either after a favorable vote by the voters of the Town of Lyme, if a referendum is requested, or if no referendum is requested upon filing with the Secretary of State.
