Article 1. - Statement of Authority. The Town Board of the Town of Lyme, pursuant to the authority granted it under Article 18 of the General Municipal Law and Sections 10 and 20 of the Municipal Home Rule Law of the State of New York, hereby enacts as follows:

Article 2. - Statement of Purpose and Findings. The Town Board of the Town of Lyme hereby finds that previous amendments to the Code of Ethics through local law #4 - 2006 need further amendment to recognize that qualified individuals should not be precluded from employment simply because of a relationship to an elected or appointed official or other employees of the Town. It is the purpose of this local law to allow an exception for the hiring, supervision and promotion of close relatives under Section 2(A) of the Code of Ethics under certain limited circumstances.

- Article 3. Enactment. The Town Board of the Town of Lyme hereby enacts amends Section $2\,(A)$ of the Code of Ethics to add a new subdivision 6 as follows:
 - 1. 6. A close relative of elected or appointed officials of the Town or employees of the Town may only be hired by a super majority vote of the Town Board (4 of 5 Members). This may occur only where the person directly responsible for supervision of that employee is not the close relative and has no direct say in the hiring, firing, or discipline of such employee or setting of compensation for such employee.
- Article 4. Severability. If any part of this local law shall be found to be void, voidable, or unenforceable for any reason whatsoever, it shall not affect the validity or enforceability of any remaining section or provision of this local law.
