Article 1. - Statement of Authority. The Town Board of the Town of Lyme, pursuant to the authority granted it under Article 16 of the Town Law and Sections 10 and 20 of the Municipal Home Rule Law of the State of New York, hereby enacts as follows:

Article 2. - Statement of Purpose and Findings. Board of the Town of Lyme has been made aware of interest in Wind Power Generating Facilities desiring to locate in the area. the same time, the Town Board is aware that there have been complaints and questions about the establishment of Wind Power Generating Facilities being located in the area. Currently, the Town of Lyme Code does not contain provisions for regulation of such facilities. Presently the Town Board has established a six month moratorium to study these issues and adopt regulations. Town Board has made progress and some additional time is needed to implement the same. It is the purpose of this local law to extend the moratorium for an additional period until January 31, 2008 on applications or proceedings of applications for Wind Power Generating facilities allow the Town Board to consider and implement sufficient regulations.

Article 3. - Enactment. The Town Board of the Town of Lyme does hereby enact as follows:

Section 1.

Commencing with the expiration date of the moratorium previously adopted and for a period until January 31, 2008, no person shall be allowed a permit to site or locate a wind power generating facilities within the Town of Lyme as defined in the prior moratorium, as amended.

Article 4. - Severability. If any part of this Chapter shall be found to be void, voidable, or unenforceable for any reason whatsoever, it shall not affect the validity or enforceability of any remaining section or provision of this Chapter.
