<u>Article 1 Statement of Authority</u>. The Town Board of the Town of Lyme pursuant to the authority granted under Section 458-a of the Real Property Tax Law of the State of New York and Sections 10 and 20 of the Municipal Home Rule Law hereby enacts as follows:

Article 2 Statement of Purpose and Findings. The Town Board of the Town of Lyme hereby finds that it has the ability to increase the exemption for Veterans from its current levels. The County of Jefferson has already increased its exemption. It is the purpose of this Local Law to adopt an exemption at the same level of the county.

Article 3 Enactment. The Town Board of the Town of Lyme hereby repeals all prior laws resolutions or ordinances enacted by it to exercise the option to reduce the Veteran's Exemptions pursuant to Section 458-a Real Property Tax Law. The Town Board does hereby adopt Real Property Tax Exemption for qualified veterans of the United States Armed Forces as provided by Real Property Tax Law Section 458-a.

Article 4 Severability. . If any part of this local law shall be found to be void, voidable, or unenforceable for any reason whatsoever, it shall not affect the validity or enforceability of any remaining section or provision of this local law.

Article 5 Effective Date. This local law shall take effect immediately upon filing with the Secretary of State.
