The Town Board of the Town of Lyme has determined that it is necessary to review water in order to generate sufficient revenues to cover all budgetary expenses for the year starting January 1, 2010. It is the purpose of this local law to amend such rates. Article 3. - Enactment. The Town Board of the Town of Lyme hereby enacts the water rates follows: District #1 Debt \$20.00 O&M \$23.00 District #2 Debt \$47.13 O&M \$23.00 District #3 O&M \$20.00 District #4 Debt \$32.00 O&M \$18.00
